

IMPORTANT INFORMATION

- Temporary EFTPOS Hire facility is only available to customers of the Warwick Credit Union, Gympie Credit Union or Dalby Credit Union.
- This application is to be completed and signed by a signatory of the account nominated for this hire.
- Incomplete applications will not be accepted.
- Terminals will not be booked until a completed form has been received and a confirmation email has been sent to your organisation.
- A hire fee of \$20 for weekend hire (minimum hire) or \$30 for weekly hire (maximum hire) will be deducted from the nominated account for this hire, unless specified and agreed to by the Credit Union.
- TYRO Transaction fees incurred by the Credit Union will be passed onto the hire customer and deducted from the nominated account for this hire, these fees are unable to be waived.
- The user of the EFTPOS terminal is responsible for its correct use and for the cost of any loss or damage that may arise from theft, vandalism, fire, flood, misuse or neglect by the user.
- Where the user damages the terminal, the Credit Union will debit the cost of repairing or replacing the terminal from the account nominated for this hire.
- As the Credit Union is the merchant, please advise all card transaction customers that their statement will show the transaction as our trading name (Warwick Credit Union, Gympie Credit Union or Dalby Credit Union) not the name of your club or organisation
